In consideration of being permitted to participate in any way, including travel to and from, in any martial art practice, tournament, clinic and related events and activities of SAN DIEGO BRAZILIAN JIU-JITSU ACADEMY (SDBJJ), Paulo Augusto and SDBJJ Teachers.

_____ I hereby:

1. Acknowledge that I will become familiar with the martial arts, self-defense and activities involved in, and will understand the rules governing them before participating in any lessons.
2. Agree that prior to participation, I will inspect the mats, equipment and facilities, and if I believe anything is unsafe or beyond my capability, I will immediately advise my instructor, supervisor, coach and/or a tournament official of such conditions and refuse to participate.
3. Acknowledge and fully understand that I will be engaging in a contact activity that might result in serious injury, including permanent disability or death, and severe social and economic losses due not only to my own actions, inactions or negligence, but also to the actions, inactions or negligence of others, the rules of the activity, or conditions of the premises or of any equipment used. Further, I acknowledge that there may be other risks not known to me or not reasonably foreseeable at this time.
4. Knowing the risks involved in this activity, assume all such risks and accept personal responsibility for the damages following such injury, permanent disability, or death.
5. Release, waive, discharge and covenant not to sue SAN DIEGO BRAZILIAN JIU-JITSU ACADEMY, PAULO AUGUSTO, together with their affiliated clubs, their respective administrators, directors, agents, coaches and other employees or volunteers of the organization, event officials, medical personnel, of her participants, their parents, guardians, supervisors and coaches, sponsoring agencies, sponsors, advertisers, and if applicable, owners, lessors and lessees of the premises used in conducting the event, all of whom are hereinafter referred to as "release", from any and all claims, demands, losses, or damage on account of injury, including permanent disability and death or damage to property, caused or alleged to be caused in whole or in part by the negligence of the release or otherwise, to the fullest extent permitted by law. I understand that I (am) am not covered by insurance other than our own policies.
6. Additionally agree that as parents or legal guardians of minor participants (age 18 and below) will instruct the minor participants to the above warnings and conditions and their ramifications, and that they consent to the minor's participation.
